**TERMS AND CONDITIONS**

1. The Quotations without Earnest Money Deposit (EMD) will be rejected.
2. Prices quoted should include all charges like GST/sales tax, Excise Duty, Octroi, Insurance, Technical Service/ Installation and Acceptance of the goods at site etc. No other charges/taxes/levies will be paid by the SUPVA during pendency of the contract/supply.
3. The firms should have a valid ISO registration certificate.
4. The firm should be registered with NSIIDC or MSME Haryana at least since last 3 years.
5. The firm should have a turnover of a minimum of INR 1.0 crore for each of last three years, or have a cumulative turnover of 3.0 crore for last three years.(Audited balance sheets to be submitted)
6. The firm should have satisfactorily executed two similar works of value Rs.3.40 Lakh & above in last three years in a Govt./semi government institute ( Completion certificates to be submitted)
7. The firm should have a minimum solvency of Rs.33000/- (Bank certificate to be submitted.)
8. The rates quoted are including the cost of material, transporting, loading and all others.
9. The quality of materials and brand name to be used shall be as specified in the original tender paper submitted by the agency.
10. The work will be done as per the CPWD specifications & on-site instruction of the Engineer in charge the technical person of the SUPVA.
11. Any failure in the structure provided and fixed by the agency, should be rectified within 24 hours of lodging the complaint.
12. The entire work shall be completed within the 30 days after 7<sup>th</sup> day of the work order failing which the Board reserve the right to impose admissible penalty for the delay of work.
13. In case of delayed completion penalty at the rate 1% per week subject to a maximum of 10% of the value of the work shall be levied.
14. In case of inordinate delay, the Registrar, SUPVA is authorized to cancel the order and allot the work to the next lowest eligible agency at the risk and cost of the defaulting tenderer.
15. Structural stability certificate shall be given by the agency for a period of 5 years.
16. The Quotation(s) must specifically mention the place and contact No. etc., from where support for maintenance work would be offered for defect liability services.
17. Appropriate penalty will be imposed in case of inferior workmanship. The material brought to site would be got checked before installation and utilization.
18. The rates will be valid for 60 days.
19. No advance payment will be made.
20. The material supplied must conform to the relevant IS Specifications.
21. No scaffolding etc. shall be provided by us.
22. The payment will be made as per the measurement and verification of the quality of work by the Engineer in charge.
23. If case of any dispute the Registrar, SUPVA shall be the sole Arbitrator and his decision shall be binding.
24. 5% security to be deposited by the successful bidder, which will be released after 6 months of successful installation.
25. Registrar, SUPVA reserves the rights to modify/increase/decrease the quantity/quality/conditions at any time without any prior notice
26. The Registrar, SUPVA does not bind himself to accept the lowest or any other bid and

reserves to him/her the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

- 27. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
- 28. The Registrar, SUPVA reserves the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
- 29. The quotation for the works shall remain open for acceptance for a period of Ninty (90) days from the date of opening of eligibility quotation. If any bidders withdraws his quotation before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the quotation which are not acceptable to the department, then the Registrar, SUPVA shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.
